**CIRCULAR**

The Rajiv Gandhi University of Health Sciences, Karnataka has planned to improve the quality of student assessment, so as to make it more compliant for competency testing in the university examinations. To enable such a goal, it is decided to capacity-build the teachers of affiliated colleges in all the areas of student assessment.

As the first step towards it, we will be focusing on the quality of Question Paper setting for the University examinations. In this regard, it is planned to provide intensive orientation on QP setting to all the teachers of affiliated intuitions in a phased manner.

In the first phase, a batch of teachers from each faculty will be trained as Master Trainer for the Project – Quality Initiatives in Theory Based Assessment (ProQIT), at the University, in batches of 30 participants from same faculty. Applications are therefore invited from all the affiliated institutions to nominate one teacher who has the aptitude and commitment to be trained, and further on, train other teachers, in the form that is herewith attached.

The teacher whom you are nominating shall have at least a Certificate of Basic Course in Medical Education from RGUHS, or an Apex Body, or the certificate of FCEM on LMS conducted by RAATI. In case the teachers do not have such certification, please contact the RGUHS Academic & Training Institute's LMS page on [support@raatilms.in](mailto:support@raatilms.in), and enrol for the FCEM on LMS Course.

The master trainer workshops are scheduled from January 2024. Therefore, you are required to lodge your applications in hardcopies to Director, RGUHS Academic & Training Institute (RAATI), Jayanagar 4<sup>th</sup> T Block, Bengaluru – 560041, on or before 22.12.2023.

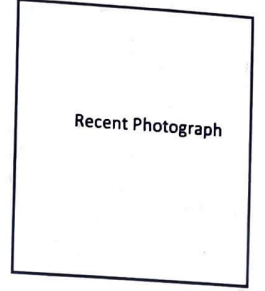
